A rapidly growing population of seniors is making the field of aging an important priority in both research and education. That is why St. Peter's and McMaster University have partnered to establish the St. Peter's Chair in Aging in the Faculty of Health Sciences at the University.

This spring, St. Peter's contributed \$1-million to fund an endowment in support of the work of the St. Peter's Chair in Aging. The University will secure funds to match St. Peter's gift.

The Chair will be responsible for vital teaching and research projects that have a direct impact on the health and wellness of older adults, as well as sharing this knowledge with other health care providers and future health care professionals.

St. Peter's gives research on aging \$1-million boost

St. Peter's expands continuum of service and care

Sharing our expertise

At the stroke of midnight on March 31, 2001, St. Peter's celebrated the first full year of management responsibilities for all of the city's complex continuing care beds.

Alliance agreements with Hamilton Health Sciences (HHS) and St. Joseph's Healthcare are making it possible for St. Peter's to share its 111 years of expertise with complex continuing care patients at our city's acute care hospitals.

St. Peter's has been providing management services to HHS since September 1999 and to St. Joseph's since April 2000. The alliance agreements allow St. Peter's to administer the funding provided by the Ministry of Health to both HHS and St. Joseph's for complex continuing care services, develop operating and capital budgets, and an annual operating plan, ensure and measure quality of care, and supervise and manage hospital staff.

We would like to acknowledge our health care partners for entrusting the care of their complex continuing care patients to St. Peter's. We believe that these types of partnerships enhance quality of care through the sharing of expertise.

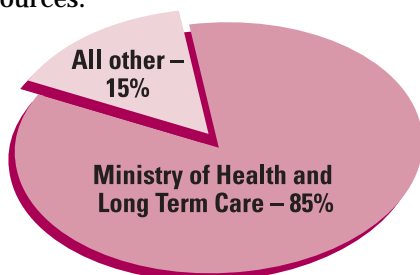

Year ended March 31, 2001

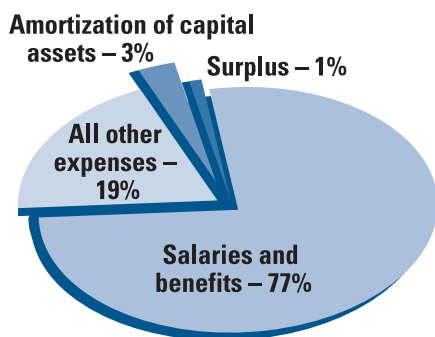

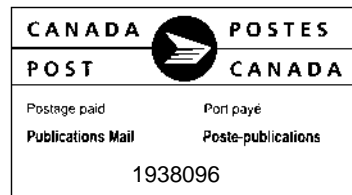
